

Ladies and Gentlemen, good evening to everyone, thank you for inviting me to present **the situation in Greece** these **last 2 years**, and to communicate to the world - together with all of you - our resistance against this **organized global torture and crimes against humanity**. I am **Nikos Vakolidis, Orthodontist, coordinator of the Greek group of World Freedom Alliance!!!**

The first case of covid was confirmed in our country **on February 26, 2020**. Then, under the slogan **“Don't become Bergamo”** the government imposed a lockdown, **second** in the world for the severity of the measures, the ban on fishing and hunting, going to the mountains and the beach, the cancellation of sports organizations, the ban on events such as weddings or their permission with limited number of people, the ban on festivals and other celebrations - which was then allowed, but with a ban on dancing. Music has been banned in bars and cafes, then allowed again, but people should sit down; **masks everywhere** - maybe made by **companies that belong to politicians** or their relatives. The **official church** reacts to the measures, but eventually adapts and recently the Orthodox Patriarch **Bartholomeos awards Bourla** for Pfizer's contribution to humanity.

**The isolation had no effect.** Total deaths from covid on 2020 are the same or even higher than those recorded for Sweden. Instead, it has caused a **socio-economic recession**, a continued increase in **domestic violence** - **15 femicides in the last 11 months!!!** **The health of the healthy has been deteriorated.**

Families, not ready for (tele)work or (tele)education, have resigned themselves to the end. **Cocaine** use has increased **5 times to date**. Along with a **60% increase in alcohol consumption and antidepressant drugs**. More than **3000 visits** in the **last 6 months have been** made in the hospital of child psychiatry of Patras of **children who during this period** have developed **depression, aggressive attitudes and suicidal thoughts**.

As **far as testing is concerned**, even in Greece we are talking about large numbers of “cases” that are exclusively positive tests, not symptomatic

and not presented compared to the total number of tests. Now the positivity rate is around 1%.

**At Cyprus**, the group AlarmCall demonstrated, after laboratory analysis of **swabs for the CoViD-19 rapid test**, the existence of a **carcinogenic, mutagenic and toxic** substance - **ethylene oxide** - at a concentration level 36 times higher than the acceptable limit.

**INTENSIVE CARE UNITS** - During the period of covid, **mortality** in ICUs in Greece reached an unacceptable **70%**. In one clinic **100%** mortality was reported. The **protocol** used is for decades totally based **on intubation**. No planning for staff training and very little use of equipment such as **high flow nasal oxygen devices** that reduce ICU admissions **by up to 50%**. The Greek association of public health workers has reported the scandalous fact of **existence of reserved ICUs for VIP patients!!!**

When the injections become available, the government cannot convince Greek citizens to take them. For young people **aged between 18 and 25**, it announces a gift of **EUR 150** for anyone who decides to receive them! Then they moved on to **indirect blackmail and restrictions on basic human rights**. Professions, such as teachers, are allowed to go to work with **2 rapid tests a week** that pay for themselves, eventually constricting themselves receiving the injections to avoid this expense. In **the summer of 2021**, those who do not get the shot have been **banned from entering indoor public places, including bars, restaurants and other places of entertainment**. By now the **so-called "operation freedom"** continues with the demonstration of **the identity card** for access to almost any private or public facility!! **The president of the union of Greek doctors, permitted himself** to point out that those who do not accept the injection and need hospitalization in intensive care **should pay the financial cost**.

**Since September**, it becomes **mandatory for health workers to** undergo injections. Thus, **10,000 health workers** have been put on indefinite

**suspension without pay.** The **Council of State** ruled that the vaccination requirement is not contrary to constitutional provisions. The government didn't stop there. Last week it announced that **citizens over the age of 60** will be fined 100 euros every month if they do not undergo the injection. In Orwellian fashion Mitsotakis said **“It's not a punishment but rather a tax on health”**.

**Margaritis Schinas**, the Greek Vice-President of the European Commission for the Promotion of the European Way of Life, revealed that Europe has already bought **injections until 2023!** He said that they have approved **drug treatments** but they don't buy them, because they want to promote pre-bought injections.

To date, around **19,000 have died of or with Covid. 95% had underlying diseases, average age 80 years (of course for the other 5% no autopsies were done).** The chairman of the Greek Commission of Experts admitted that they have recorded deaths from other causes as covid because the deceased was positive in a test. In Greece, **by law**, members of this and other relevant commissions **cannot be held responsible, prosecuted or investigated for opinions expressed** or votes given in the performance of their duties.

**After the injections, total population mortality** from all causes **increased by 39% in Greece** in the last seven months, about **1000 deaths per month** more than expected. This increase **in Cyprus is 55%.**

**Possible causes - Exercise restriction**, people's **fear of** going to hospital; the **psychological burden** of house arrests, **untreated diseases** after the conversion of many **health facilities to Covid-19 clinics**, clinic closures and suspension of surgical procedures **due to suspension of health workers**, and probably **the injections themselves.** The **non-existent pharmacovigilance** obviously does not help to investigate this hypothesis. Until recently neither citizens nor physicians were informed about the procedure of recording side effects through **the Yellow Card.**

The state preferred to **spend** on strengthening **the police and the military** by buying cars, weapons, planes and naval ships, **compensate big businesses**, such as airlines, for their losses due to the lockdown, and pay **the media 30 million** to promote its propaganda.

The  **censorship and defamation of the opposite opinion** is continuous, leading to the **loss of** university professors' **seats** and **the professional licenses of** doctors who have spoken out against the measures.

In the meantime, the state went ahead by amending the Criminal Code. Specifically, the **Article 191** establishes **penalties** for “whoever publicly or through the internet spreads or disseminates, in any way, **false news that may cause alarm or fear to the public or undermine public confidence in the national economy, the country's ability to defend itself, or public health.**” offenders “shall be punished by imprisonment from **three months to five years** and financial penalties”.

Ladies and gentlemen, I didn't say that. **Elytis**, the Nobel Prize-winning Greek poet... “It's **barbarism**. I see it coming in disguise, under **illegal alliances** and **predetermined enslavements**. Perhaps it won't be Hitler's gas chambers, but a **methodical, almost scientific subjugation of man**. For his/her complete **humiliation**. For his/her **disgrace.**”

We, however, have news today for the orchestrators of this crime against us. **We are the 99%**. We are numerous and this is our strength. **We are free by nature** not by law. We would make the world what we want it to be, and **we will ask permission of no one**.
